## Islington Play Association awarded a quarter of a million pounds to enable children to design and build tree houses in Islington

On Tuesday 10th February at Islington Town Hall, Islington playworkers, council officials, councillors and the press gathered together to launch the start of Islington Play's new Tree Houses for Kids Project.

The Chief Executive of the Big Lottery Fund was there in person to present Islington Play with a cheque for £245k. The project, which will run from March 2009 to early

2012, will enable children at 24 sites across the borough to build their own treehouses, shelters and dens under the guidance of specialist play professionals.

# IPA updates

## Treehouses for Kids: project update

We are delighted to announce we have just appointed a specialist playworker to deliver our long-awaited 'Treehouses for Kids' project. Our very own Wendy Jeeves, from Three Corners Adventure Playground in Clerkenwell, will be building treehouses, dens and shelters with children at Islington's 12 adventure playgrounds (as well as 12 other sites) over the next three years. She will be working closely with the Royal Society for the Prevention of Accidents (RoSPA) to make sure we minimise hazards whilst offering excitement and acceptable risk.

As the project is going to be led by children, we won't be working from pre-conceived designs. The adults' role will be to supervise the safe use of tools and intervene only if necessary. As such, we are hoping to establish a culture of free play and constantly changing children's spaces.

We still believe that play spaces need to be adaptable by children, even if that means that they take down (and re-build) their creations when they become boring. Large loose parts (such as timber, fabric, tyres, rope etc.) are a great way to do it. This approach is easy to put into practice in playworker supervised, fenced-off spaces (such as adventure playgrounds) which are relatively safe from trespassers at night.



The children will be building in trees wherever they are present on playgrounds and other sites. Where there are no trees, we will allow the children to think about spaces they want to create and how we can help them do it. We will also be working closely with Greenspace and other partners to make sure that we use the correct techniques to minimise damage to any of the trees that will house the children's constructs.

There is the possibility of having treehouses on one or two sites in public places (parks etc.) which will be accessible by the public and not supervised by playworkers. In these cases we will have to think of more permanent structures, which we will base on treehouse designs from around the world.

All in all we are extremely excited by this project and will be reporting regularly on its progress at

regional and national conferences, as well as through various publications - watch this space! We will also be producing a 'how-to' manual, so that children and their families can safely share in this thrilling experience up and down the country.



# More IPA updates



## PIP: findings at the half-way stage

It's nearly the end of Year One of the Play Improvement Project (PIP) at IPA, and we've been getting busier and busier. We've been going to each Adventure Playground in turn, seeing what we can do to help improve access and inclusion across the borough. This help has been varied and can range from providing free training or resources, or making contacts with individual area residents or groups such as Centre 404.

To help promote access to adventure play, each Adventure Playground will get its own free flag and flagpole, designed by the children onsite. This will put play right on the local skyline, and by the raising of the flag make sure that all children know when play is "in session".

The March Sunday openings (11am-3pm) of our children and families café at Paradise Park Children's Centre are going from strength to strength, providing us with an ideal platform to meet and chat with

local residents about their play needs, and to introduce children to Adventure Playground ideas through the mini-Adventure Playground of the nursery garden. Open until Sunday 5th April, the café has a different theme each week. Food is 50p a plate for children and young people, and £1 a plate for adults. The final Sunday event is on April 5, when the Eden Project will be coming up from Cornwall and leading a public den-building session in Paradise Park. All welcome! ## A fond farewell to Bob Hughes after almost four years work at the IPA

Bob Hughes, winner of the 2008 Lifetime in Play Award, play theorist, academic and author with an international reputation has made a fantastic contribution to the work of the IPA over almost four years. His best-known work has been around "play types" (A Playworker's Taxonomy of Play Types 2001) and evolutionary play theory (Evolutionary Playwork and Reflective Analytic Practice 1996). He created and sustains Playwork Education which informs state of the art playwork training and education. In short he is one of the most significant people working in the field of children's play and we have had the privilege of having him on the staff team of the IPA!

Of course, working with Bob has been challenging! It is not always easy to be made to think and re-think what you are doing and why. Bob was hired to advise and enhance the work of the IPA on a programme to promote novel modifications on Islington's adventure playgrounds that would reflect children's play choices and needs as well as specifically promoting physically active play. His contribution has been considerable. Bob's work with the IPA is one of the reasons why Islington has the best adventure playgrounds in the UK!

Everyone at the IPA expects a special relationship to be sustained into the future and we see his continuing advice and guidance as of great value to our ongoing work.

### Playwork and the Early Years Foundation Stage (EYFS): an update

The government have made assurances that as long as Playworkers are adhering to the Playwork Principles, those working with children aged 4 and 5 will be in a good position to meet the EYFS requirements.

- The assessment scales (appendix 1 of the Statutory Framework for the EYFS) will be completed by the primary setting where the child spends the majority of their time between 8am to 6pm. In term time this is school.
- During holidays, although children may be spending a large proportion of their time at the play-schemes, taking into consideration the whole year, they still wouldn't be the primary setting.
- There is an expectation for playworkers to keep up with and improve on existing good practice.

### Quality in Play (QiP) update

The new manual is now available through Play England. There are only 11 areas grouped under 3 headings: the play environment, the organisational framework and the wider context. There is one level of achievement that can be boosted to

an additional excellence award for providers showing significant and sustainable good practice.

### Change to CRB checks

The government has handed control of vetting and barring of children's workers over to the Independent Safeguarding Authority (ISA). All employers must send their referrals to list 99 and the Protection of Children Act list—which record the names of people banned from working with children—to the ISA at: Independent Safeguarding Authority, PO Box 181, Darlington DL1 9FA. Until October 2009 the process of applying for CRBs will stay the same. ## Minimum wage information

The minimum wage increased from 1 October 2008:

- From £5.52 to £5.73 per hour for over-21s
- From £4.60 to £4.77 per hour for 18-21 year olds
- From £3.40 to £3.53 for 16 and 17 year olds who are above school leaving age and are not apprentices

## Statutory annual leave entitlement

From 1st April this year the statutory annual leave entitlement will increase from 4.8 weeks to 5.6 weeks

### Voluntary sector adventure playground funding!

Play England has been contracted by the Department for Children, Schools and Families to manage a funding programme for refurbishment of adventure playgrounds run by the voluntary and community sector. £1.5 million will be made available through the programme, which will run from April 2009 to March 2010, and **all eligible third sector-managed adventure playgrounds may apply for up to £19,000 to update and modify their play spaces.**

### Community Resilience and Modernisation Fund

A £15.5 million Community Resilience Fund will provide grant funding to small and medium providers in communities most at risk of increased deprivation due to the recession. This is in addition to the £130 million already committed to the Grassroots Grants programme meaning more small grants to more community groups.
